### SALUS 'Win a Van' Prize Draw Terms and Conditions

By participating in this promotion you are agreeing to these terms and conditions.

#### 1. **The Promoter**

- 1.1. The Promoter is: Salus Controls PLC of Units 8-10 Northfield Forge Way, Parkgate, Rotherham, Yorkshire, England, S60 1SD.

#### 2. **The Promotion**

- 2.1. The title of the promotion is "SALUS 'Win A Van' Prize Draw" ("the **Promotion**").

#### 3. **Key Conditions of the Promotion**

- 3.1. The Promotion is an offer by the Promoter, allowing a participant to enter a prize draw for the chance to win a prize as detailed in these terms and conditions.
- 3.2. Entrants must be registered installers, aged 18 or over and UK resident. You must provide at least one of these: a valid Company Registration Bumber or Company VAT Number or Gas Safe number or OFTEC Registration Number. To enter you must complete an online form at <https://saluscontrols.com/gb/meet-allen-hart> between **00:00 (GMT) on 2 July 2024** and **23:59 (GMT) on 30 September 2024** ("**Promotion Entry Period**") in order to be in with a chance of winning. The prize draw will take place on or before 15 October 2024 and will select 27 winners at random. One winner will receive a BYD ETP3 Pure Electric Panel Van ("**Van Prize**") and the remaining winners will receive a runner-up prize ("**Non-Van Prize**"). Further details of all prizes available to be won (the "**Prizes**") are set out in Section 6 below.
- 3.3. Entries must be submitted online via <https://saluscontrols.com/gb/meet-allen-hart> during the Promotion Entry Period. Further details of the entry requirements are set out in Section 5 below.
- 3.4. You may only enter the Promotion once.

#### 4. **Eligibility Requirements**

- 4.1. The prize draw is open to all registered installers that provide at least one of these: a Company Registration Bumber or a Company VAT Number or a Gas Safe Number or a OFTEC Registration Number, who are UK residents (not applicable for the Northern Ireland and or Channel Islands residents) and aged 18 years or over.
- 4.2. The Promotion is not open to (i) employees or agents of the Promoter, City Plumbing Limited or BYD Europe B.V. or their group companies (or members of the immediate families or households of such individuals); or (ii) any third party directly associated with administration of the Promotion.

4.3. In participating in the Promotion, you confirm that you are eligible to do so and eligible to enter. The Promoter may require you to provide proof that you are eligible to enter the Promotion before issuing any Prize.

## 5. **How to enter**

5.1. The Promotion is free to enter and no purchase is necessary.

5.2. 5.4. The Promoter may also require you to provide proof of identity (such as a copy of your passport or driving licence) and proof of UK residency.

5.5. ## 6. **Winner Selection and Prizes**

6.1. Following the end of the Promotion Entry Period, the Promoter will identify and collate all entries that were received during the Promotion Entry Period. For these purposes, an entry will be deemed to have been received when you have completed all the steps set out in Section 5 ('How to Enter') and your entry form has been successfully received by the Promoter. Any entry forms received by the Promoter after **23:59 (GMT) on 30 September 2024** will not be eligible for participation in the Promotion.

6.2. SALUS Controls reserves the right to verify the information provided and may request additional documentation to confirm eligibility. Campaign participants declare on their own responsibility that all the information provided is accurate. Submission of false or misleading information may result in immediate termination of your registration.

6.3. Winners will be chosen by random draw performed by a computer process on or before 15 October 2024.

6.6. Prizes are subject to availability, non-exchangeable, non-transferable and the Promoter reserves the right to substitute these Prizes with similar prizes of equivalent or greater value. No cash alternative will be offered or given.

6.7. **Winner Notification:** The winners will be notified by email or telephone (using details provided at entry) before **29 October 2024** and must provide a postal address and any other information reasonably requested by the Promoter to claim their Prize. Winners must respond accepting the Prize and provide all details required by the Promoter within 30 days of being contacted by the Promoter. If a winner does not respond to the Promoter within 30 days of being notified by the Promoter, then the winner's Prize will be forfeited and the Promoter will be entitled to select another winner in accordance with the process described above.

6.8. **Prize Delivery:**

6.8.1. Non-Van Prizes: Non-Van Prizes will be dispatched for delivery to the winner's chosen address (in the UK - not applicable for the Northern Ireland and or Channel Islands residents) within 28 days of the Promoter receiving all required information from the winner.

6.8.2. Van Prize: Arrangements will be made with the winner of the Van Prize for the Prize to be collected by the winner from a UK location and on a date specified by the Promoter ("**Collection Date**"). With effect from the Collection Date, the winner of the Van Prize will be responsible for (i) complying with all applicable legal requirements to enable their legal ownership and use of the Van Prize (such as insurance, registration and taxation of the vehicle); and (ii) all maintenance, running and other costs and expenses applicable to the usage of the Van Prize.

**6.9.** The Promoter will provide the winner of the Van Prize with details of any remaining warranty which may be applicable to the Van Prize.

**7. General**

7.1. The Promoter accepts no responsibility for entries not successfully completed due to a technical fault, technical malfunction, computer hardware or software failure, satellite, network or server failure of any kind, except in cases of negligence, fault or deliberate act or omission of the Promoter or its agents.

7.2. The Promoter will not accept responsibility for any Promotion entries which are rejected or cannot be verified within the required timeframes or for any other issues, due to the provision by a participant of incorrect or incomplete information or contact details.

7.3. The Promoter cannot accept responsibility for problems arising from entrants providing incorrect or out of date contact information with their Promotion entry.
